**Title of Investigation:** MRI: Development of High-Order Adaptive Optics for the 1.6 Meter Solar Telescope in Big Bear

#### **Project Summary**

New Jersey Institute of Technology (NJIT), in collaboration with the University of Hawaii (UH) and the Korean Astronomy and Space Institute (KASI), is nearing first light with its 1.6 m clear aperture, off-axis, New Solar Telescope (NST). It has replaced Big Bear Solar Observatory (BBSO)'s principal telescope, which has an 0.6 m aperture. The NST will be the largest aperture solar telescope, and it will play a leading role in solar physics research and education. Under prior NSF/MRI support to NJIT, in collaboration with the National Solar Observatory (NSO), we have successfully developed two 76-element (with 97-element Deformable Mirror) Adaptive Optics systems (AO-76) for the just retired BBSO 0.6 m telescope and the NSO 0.7 m Dunn Telescope, respectively.

An AO system to match the 1.6 m aperture is essential to achieve the scientific goals of the NST. BBSO AO-76 was a high-order system for the 0.6 m telescope, and was successfully operated in both the visible and near infrared (NIR) ranges. With a ATI grant we have re-designed AO-76 to fit NST, and have acquired necessary hardware for this transfer. AO-76 is insufficient for reliable correction in the visible for the NST. This proposal seeks funding to build a 308 sub-aperture (349 element Deformable Mirror) AO system for the NST. We have carefully estimated that under median seeing conditions at BBSO, the predicted Strehl ratio at 0.5  $\mu m$  will be often above 0.5 with AO-308. The key tasks in this proposal include the final optical design, the building of the electronics system and the subsequent setup/testing of the AO system utilizing the NST. Our benchmark is a design that will be as reflective as possible to make the system as achromatic as it can be.

The principal scientific objectives for the AO equipped NST are campaign observations in: (1) high cadence, high resolution studies of solar flares; (2) evolution of magnetic fields associated with solar activity; and (3) dynamics of kilo-Gauss magnetic flux tubes. Our campaigns will often be in collaboration with NASA Missions to maximize scientific synergy to better understand our star. In sum, we directly address the two criteria required in any NSF proposal:

(1) Intellectual merit: National Solar Observatory (NSO) is planning to build its flagship telescope for the community: the 4 m Advanced Technology Solar Telescope (ATST). As we have collaborated and will continue to collaborate closely with NSO, the AO-308 would be a test bed for even larger AO for ATST. While the ATST's primary science focus is on the physics of small scale flux tubes and the solar corona, the NST with BBSO's unique seeing conditions, will enable new, cutting edge science in the study of solar activity. Even after the ATST is on-line, the NST will continue to be an essential telescope in making campaign-style observations. We have in place the similar team used in the AO-76 project for AO-308, and in this we have already demonstrated our abilities by developing these two most successful solar AO systems. The tasks of the NST and AO teams are clearly defined, delineated and separated, although two teams work closely.

(2) Broad Impact: The development of the proposed AO system will enable us to further explore Multi-Conjugate Adaptive Optics (MCAO) in AO-308, again in close collaboration with NSO. This effort is highly relevant to the development of MCAO systems for nighttime telescopes. The scientific results will be extremely important in the understanding of the dynamics of magnetic fields on a fine spatial scale, as well as space weather monitoring and forecasting. A Ph. D. student and a post-doc will participate in the project. The resulting data will be used in many Ph. D. theses. Our data will be open to the scientific community, and about substantial portion of observing time will be open to the community.

# **A Project Description**

# A.1 Research Activities

The high resolution NST will continue the unique BBSO tradition of campaign observations that are often in collaboration with NASA Missions to maximize scientific advances to better understand our star. We believe that a more fundamental understanding of solar magnetic fields and the solar atmosphere depends on sustained, higher resolution and higher cadence observations. Over the past few years, we have substantial scientific and instrumental accomplishments that position us to advance to the next level of our scientific objectives, which will center on understanding energy release and transport on various scales in the solar atmosphere, as well as the associated evolution of magnetic fields. Our research requires a continuing effort in instrument development, and a dedicated scientific team to make and analyze new observations. Building the new, off-axis 1.6 m clear aperture telescope at BBSO, a project nearing its first light, is a crucial step toward this goal.

The Advanced Technology Solar Telescope (ATST) site survey was initiated in 2000 and identified at the end of a four-year survey three excellent sites for solar observing: Big Bear Solar Observatory, California - Mees Solar Observatory, Haleakala, Maui, Hawaii - Observatorio Roque de los Muchachos, La Palma, Canary Islands, Spain (Hill et al. 2004). All three sites are suitable for high-spatial resolution observations. Haleakala and La Palma have strong advantages for coronal science. However, only BBSO - the mountainlake site - provides consistent Adaptive Optics (AO) correctable, seeing conditions with extended periods of excellent seeing from sunrise to sunset without having raise the telescope above ground (see Figure 1). For any modern, ground-based solar telescope, an AO system is required to correct seeing induced image smearing and distortions. A minimum Fried parameter of about 6 cm is required for AO correctability. Obviously, BBSO is a unique site for locating a large aperture solar telescope because it achieves diffraction limited resolution with AO for many consecutive hours, day after day. As the ATST will be built 28-meters above the ground in, periods of excellent seeing can be found in the mountain-island sites. Haleakala was selected as the ATST site because of the ATST's primary scientific objectives: studying the physics of the solar corona and detecting the extreme fine structure of magnetic fields, which can be usefully studied with exceptional seeing for certain periods of time. The lake at BBSO provides a natural inversion, which effectively suppresses the boundary layer and makes the observatory ideally suited for sustained, highresolution and synoptic observing programs, and the 1.6 m New Solar Telescope (NST) is being built for these purposes, and more.

We now review our significant progress on two major instrumentation projects that are relevant to the development of the proposed AO system: the on-going NST project and the completed 76-element AO project.

#### A.1.1 New Solar Telescope at BBSO

Supported primarily by a NSF MRI grant (ATM-0320540), BBSO/NJIT, in collaboration with the University of Hawaii (UH) and Korean Astronomy and Space Institute (KASI), has replaced its old 0.6 m aperture telescope with a modern, off-axis 1.6 m clear aperture instrument with a  $120'' \times 120''$  field of view (FOV) (Goode et al., 2003). The new telescope offers a significant improvement in ground-based high angular resolution capabilities, and enhances our continuing program to understand photospheric magneto-convection and chromospheric dynamics. These are the drivers for what is broadly called space weather – an important problem, which impacts human technologies and life on Earth. The NST is a whole new system starting with being the largest aperture off-axis telescope. We have made very near first light in this project, including have figured of the largest aperture, off-axis primary mirror, the ongoing construction of the optical support structure with active optics, a new dome to house the larger telescope, and a whole new control system.

The project is described in detail in <u>http://www.bbso.njit.edu/newtelescope</u>. To minimize risk, we borrowed from the design of existing telescopes as much as possible. For example, the new, larger dome follows the SOAR design using the same vendor, with minimal, but required modification: the NST dome has louvers to ensure proper airflow inside the dome, and so this and other improved thermal properties of the new dome will solve the long-standing dome-seeing problem at BBSO. The NST optical and software control designs are similar to the existing SOLAR-C (UH) and the planned ATST facility led by NSO – all three are off-axis designs. Furthermore, we had two independent groups do the complete Finite Element Analysis (FEA), and obtained similar results. We have full funding for the NST, except for the funding for its AO system. Figure 2 shows the mechanical schematics and optical layout of NST. Full operation is expected by the Spring of 2008. The specific details of our progress are:

The telescope has a 1.7 m primary mirror with the 1.6 m clear aperture. It has an off-axis Gregorian configuration consisting of parabolic primary, heat-stop, elliptical secondary and diagonal flats. The focal ratio of the primary mirror is f/2.4, and the final ratio is f/50. The working wavelength range will cover from 0.39 to 1.7  $\mu$ m in the Coude Room beneath the telescope and all wavelengths including far infrared at the Nasmyth focus on the dome floor. We chose an off-axis design primarily because of its vastly reduced stray light, since there is no central obscuration, which reduces the telescope's MTF (Modulation Transfer Function) at high spatial frequency. This makes it an excellent test bed for the ATST and its hardware.

We have designed an open telescope structure with an equatorial mount. A key design issue for a large aperture, open solar telescope is the thermal control system to keep the temperature of the mirrors very close to, or below that of the ambient air. We are using a wind-gate system in the new dome (discussed below) to control the airflow from the wind and help maintain the same temperature inside and as outside the dome. In addition, we have implemented an airknife system to limit so-called "mirror seeing". After a day of observation, we will blow the wind overnight to ensure it is cooler than ambient in the morning. From the outset, the central and risky part of the NST project was the figuring of the off-axis, primary mirror to high optical quality. The Zerodur primary mirror was configured and polished at Steward Observatory Mirror Lab, University of Arizona (UA Mirror Lab), as part of their 20/20 project (http://www.optics2001.com/We believe this was the optimal facility for figuring the NST primary mirror. The lab was funded to polish a fast, off-axis 1.7 m mirror as a proof-of-concept study for figuring seven 8.4 m mirrors for twin 21 m telescopes. The end product of the proof-of-concept will be the primary mirror for the NST. The precision of the primary is 10 nm rms. For the testing of the figure, Steward built a testing tower and used novel holographic testing system to account for the off-axis nature of the mirror.

The new, larger dome, required to house the NST, is fully operational and all construction under the dome (such as the extension of the support pier) has been completed and awaits the telescope. The elliptical secondary mirror (SM) is finished and silvered, and has been tested by SORL and Steward. The PM is active, and its shape will be controlled by a wavefront sensing system from Wavefront Sensors (http:????), which will reside after the SM. This is in-house and is being tested but will not be used at the first light. The heat stop is completed and its attachment at prime focus is being assembled. The opening in the heat stop defines the  $150'' \times 150''$  field of view of the NST. The Optical Support Structure (OSS) was built by DFM Engineering, Inc. of Longmont, CO and has been installed in Big Bear (before proposal deadline). The first draft of the BBSO telescope headquarters control system software has been written.

# A.1.2 Adaptive Optics

Under a prior NSF MRI grant (AST-0079482), we have successfully built two high-order AO systems (76 element deformable mirror AO systems), one for BBSO's 0.6 m telescope and the other for the 0.7 m Dunn Solar Telescope at National Solar Observatory/Sacramento Peak (NSO/SP). Dr. Thomas Rimmele of NSO, as a Research Professor at NJIT, was the PI of the project. He will participate in this proposed project as a Co-PI. A number of papers have been published to describe these two AO systems and the scientific results (Ren et al., 2003a; Didkovsky et al., 2003; Denker et al., 2005,2007; Rimmele, 2004; Yang et al., 2004; Tritschler et al., 2005; Xu et al., 2004, 2006, Cao et al., 2006). Figure 4 shows a sample image obtained on April 29, 2005 with the BBSO AO system. The performance of the BBSO AO system is evaluated in Figure 5. The figure compares the variances of the Zernike coefficients for modes up to order 35, for AO-off and AO-on data (Tritschler et al., 2005). The Fried parameter for this particular data set is 5.4 cm, slightly lower than the value of the median seeing at BBSO. The variances are a factor of 100 smaller for the AO-corrected data. Therefore, the mean wavefront abberation is 100 times smaller after the AO-correction. The temporal variances were determined from time sequences of about 10000 AO measurements over the entire pupil.

With a support of NSF ATI grant, The AO-76 system has been redesigned to fit the NST. Figure ? shows it final design. All hardware are in place awaiting for the installation of NST.

### A.1.3 Near Infrared and Visible Imaging Vector Magnetograph Systems

BBSO has built and employed several generations of near IR imaging systems. The most recent and significant part of our IR instrumentation was the development of a narrow bandpass filter system, which combines a Lyot filter and an IR Fabry-Pérot filter – the IR Imaging vector Magnetograph (IRIM). The filter has a bandpass of 2.5 Å at 1.56  $\mu$ m, giving us a 2.5 Å wide prefilter (narrower than the 5 Å free spectral range of the IR Fabry-Pérot). The Lyot filter was designed as part of the Ph. D. thesis of a now graduated student, and the filter solves the longstanding problem of constructing a filter-based IR magnetograph, while avoiding the complications of using a double etalon. We have obtained and implemented a large format IR CMOS camera (1k×1k, 30 frames/s) from Rockwell Scientific Imaging (now Teledyne). We enjoyed a very successful first scientific light of the full IRIM hardware system in November 2004 at NSO/SP and in July 2005 at BBSO. The strength of the IRIM is its extreme sensitivity and high spatial resolution, which allows us to study weak and small-scale magnetic fields in the quiet Sun. In active regions, it enables accurate measurements avoiding Zeeman saturation of the traditional filter-based magnetograph systems. Both magnetic field strength and the filling factor were derived from fitting the Stokes V profiles (Cao et al., 2006). Although IRIM has many advantages on its own, to achieve the highest spatial resolution with NST, we must emphasize instrumentation in visible. We have developed a Visible Imaging Magnetograph system (VIM) that is tunable from 400 to 700 nm with a bandpass of 0.01nm (Denker and Tritschler, 2005). This system has also achieved its first light recently at BBSO. With AO correction, NST will achieve diffraction limited images with a spatial resolution of about 50 km, when observations are made at 500nm (better than three times the resolution possible in the near-IR with the NST).

#### A.1.4 Science Drivers for the AO Equipped NST

As will be seen in the next section, when observing in the visible with the NST, AO-76 can achieve 50 km resolution with Strehl above 0.5 occasionally when  $r_0$  is above 12 cm. We propose to build 308-actuator (349-element deformable mirror) system. AO-308 can achieve 50 km resolution with Strehl above 0.5 more than half of the time that will be demonstrated later. Therefore, campaigns following the evolution of magnetic fields and flows for several hours continuously with such a Strehl, sub-arcsec resolution will be a unique feature of AO-308 equipped NST, even after ATST is built, it will remain as an instrument to be in campaign mode for the study and monitoring of solar activity and space weather. The following scientific objectives reflect such a unique capability.

We need to develop the AO-308 as soon as possible for the following reasons: (1) Solar activity maximum is coming in about three years, full resolution NST will play a significant role in the study of solar activity. (2) NST will support a number of solar missions, STEREO, Hinode, and SDO (in 2008). (3) Development of AO-308 early will benefit ATST project as soon as possible.

(a) High Cadence, High Resolution Studies of Solar Flares

One of the most important but not well-understood areas in flare research is the fine temporal and spatial structure of flares, so called "elementary bursts" (see Sturrock, 1989 for the review). The 1.6 m telescope will obtain high resolution, high cadence images of flares. These observations will provide details of electron precipitation on fine temporal and spatial scales. We expect to learn if, and how the individual sub-second peaks in the hard X-ray and microwave time profiles correlate with the rapid precipitation along various flux loops. Xu et al. (2004, 2006) presented the very first high resolution observations of an X10 white-light flare (from solar active region NOAA 10486 obtained with the Dunn Solar Telescope at NSO/SP on 2003 October 29, with AO-76). The study demonstrated the potential of obtaining the new science when the high resolution photospheric observations are combined with hard X-ray imaging and spectroscopic observations; however, even with a resolution approaching 100 km, the flare ribbons were not resolved. We anticipate that

NST will provide new and basic insight into this problem.

(b) Structure and Evolution of Magnetic Fields and Flow Fields in Flaring Active Regions

It is generally accepted that the energy released in solar flares is stored in stressed magnetic fields. So, the study of magnetic fields is a very important component of flare science. This concept of energy release has motivated many attempts to detect flare-induced changes in the magnetic fields of active regions. Until very recently, no one has detected, in any consistent way, the changes in magnetic fields associated with solar flares. The BBSO group first saw signs of these changes using BBSO, TRACE and MDI one-minute cadence data (Spirock et al., 2002; Wang et al., 2002, 2004; Liu et al., 2005). The inconsistency among the results is due to observational limitations. We cannot get high temporal and spatial resolution and high polarization accuracy at the same time, with existing telescopes/instruments. NST equipped with AO-308 will provide much more reliable and high quality measurements of vector magnetic fields. A consistently high Strehl ratio will ensure that the detected field variations will not be due to variation in seeing conditions. More specific scientific questions to be answered are: (1) What is the role of the evolution of the photospheric magnetic field in triggering solar flares, and what is the relationship between the magnetic configuration and the properties of flares? (2) How do electric currents evolve, and what is their relationship to particle precipitation?

### (c) Dynamics of Kilogauss Flux Tubes

Understanding the dynamic behavior and structure of small scale kilo-Gauss fluxtubes is a primary scientific goal of the ATST. Since the NST will commence observations at least 6 or 7 years before the ATST, we will certainly heartily attack this problem with the AO-quipped NST. The key issues are the formation of photospheric flux concentrations having field strength above the equipartition field strength and the dynamic interaction with the turbulent photospheric atmosphere. Understanding the dynamic interaction of photospheric flux concentrations with turbulent granulation is also essential in order to estimate the total energy flux that is transmitted/channelled by small-scale fluxtubes into the higher atmosphere. The key questions are: How are fluxtubes formed and how do they evolve? What is the lifetime of a fluxtube? How do fluxtubes interact with the turbulent flows in the photosphere? The observational determination of the process(es) that leads to kilo-Gauss flux concentration in the solar photosphere, where the equipartition field strength is only about 500 G, is a fundamental problem in solar and stellar physics that needs to be solved, and 50 to 100 km resolution is critical to resolve this problem. The results will aid further investigation using ATST. In the shorter term, multi-wavelength investigations using NST and satellite data to study this problem will advance our understanding of flux tube physics.

# A.2 Description of Research Instrument and Needs

As discussed above, with its 1.6 m aperture, the performance of the NST will be significantly improved if AO is available to correct the wavefront errors caused by atmospheric turbulence. We propose to develop a new AO system for the NST, which follows the concept of the current AO system of the 0.6 m telescope, but with significantly improved optical design and hardware upgrades. The current BBSO AO-76 has been proved to be successful and has delivered excellent diffraction-limited images in the visible and NIR with the BBSO 0.6 m telescope (Rimmele et al. 2003, Ren et al. 2003a, Didkovsky et al. 2003, Tritschler et al., 2005). These demonstrate our technical ability and give us the confidence that we will build the AO-308 system in an optimal way. We emphasize that AO-308 is essential to reap the full benefits of the investments in the NST.

#### A.2.1 Evaluation of the Strehl Ratio

The AO design parameters are driven by the telescope properties as well as the seeing conditions at the site. In general, the seeing (Fried) parameter  $r_0$  is used to quantify the seeing conditions at a site.  $r_0$  is the

coherence length of the atmospheric turbulence. For telescope apertures larger than  $r_0$ , resolution is seeing limited. The Fried parameter is wavelength dependent( $r_0 \propto \lambda^{\frac{6}{5}}$  for Kolmogorov turbulence).

As stated above, the NST has an aperture that is about three times that of the current 0.6 m telescope. Thus, the AO-76 system could fully correct the atmospheric turbulence at 1.6  $\mu m$  in the NIR. The median seeing at BBSO is about  $r_0= 6$  cm at 0.5  $\mu m$ , while it is 24 cm at 1.6  $\mu m$ . A higher order AO must be developed for NST to observe in the visible in campaigns, while probing with spatial resolution of about 50 km. One must bear in mind that spatial resolution decreases linearly with wavelength.

The Strehl (S) ratio, which is the ratio of the maximum intensity in the AO corrected image to that in the diffraction limited image, is generally used to quantify the performance of the AO system. Figure 6 plots the expected Strehl ratio vs. the number of corrected modes, using  $r_0$  as a parameter. It does not consider the noise the WFS images. As can be inferred from the theoretical Strehl ratios in Figure 6, even moderate variations in  $r_0$  will result in large variations in the Strehl, if only a small number of Zernike modes are corrected. This is mostly due to additional aberrations in higher order Zernike modes, which increases as  $r_0$  decreases. Therefore, in order to minimize seeing induced variation in image contract, high order AO is needed.

At 1.6  $\mu m$ , when the median  $r_0$  is 24 cm, a 76-mode correction would achieve a median Strehl ratio of 0.84. While in visible at 0.5  $\mu m$ , the median  $r_0$  is 6 cm, the corresponding Strehl ratio is 0.18. If the correction order is increased to 308, the Strehl ratio will be 0.60 for the visible, reaching a satisfactory correction level above 0.5 (Wizinowich et al., 2004). Conservatively, due to noises in the WFS system, if we assume correction mode is half of 308, the Strehl is still 0.4. Fig. 5 already demonstrated that the correction at half of 76 mode in AO-76 is still significant.

Anisoplanatism causes the quality of the AO correction to gradually decline with distance from the chosen isoplanatic patch. This dropoff will become more appreciable as the Strehl decreases. One may argue that post-processing such as speckle reconstruction may restore contrast of AO corrected, but low Strehl ratio images. However, speckle requires multiple input images to construct one output image, therefore, one cannot expect to achieve our essential goal of sub-second cadence with post-processing.

#### A.2.2 Overview of the AO Development Effort

The conceptual design of the operating BBSO AO system is quite straightforward. A beam splitter directs a light beam to the wavefront sensor (WFS) that does the following: 1) The telescope aperture is sampled by a lenslet array, which in turn forms an array of images of the object (e.g. granulation) to be imaged by a camera with a better than kHz frame rate. 2) Cross-correlations between subaperture-images and a selected reference subaperture-image are computed via a very fast computer-Digital Signal Processor (DSP). 3) Local wavefront tilts are computed by locating the maximum or centroid of the cross-correlations (CC) to subpixel precision, and 4) Drive signals for the Deformable Mirror (DM) are derived from the wavefront sensor data using a modal wavefront reconstruction algorithm (e.g., Madec 1999). With sufficiently good seeing, the WFS is capable of using solar granulation, or other time varying, low contrast, spatially extended targets to measure the wavefront aberrations. The bandwidth of the correction for AO-76 was 135Hz in its closed-loop mode. With much improved computing speed now available and a newly developed DM, we anticipate achieving a similar bandwidth for AO-308, which is good enough for 0.5  $\mu$  light. As we stated, experiment with AO-76 adapted to NST will aid the development of AO-308.

For AO-308, the wavefront sensor will be a correlation Shack-Hartmann WFS. The WFS is designed to be able to process up to 360 sub-apertures. The wavefront sensor detector is a Phantom V7.3 camera that has 800 by 600 pixels (300 by 300 to be used). It has a frame rate over 6000 fps, but we will only utilize 2000 fps. Therefore, each sub-aperture will be characterized by  $20 \times 20$  pixels. The tip/tilt mirror will be mounted on a Polytec PI S-340 piezo tilt platform, and the DM will be manufactured by Xinetics, Inc. The new high density DM just became a standard item, facilitating the design of the AO relay optical system. The WFS has 308 effective elements, while the DM also has 349 actuators.

#### A.2.3 Optical Design

Our proposed effort involves the design and assembly of a new optical system for AO-308. Nicolas Gorceix is in charge of this new design work. There are some requirements for the optics of the new NST AO-308 system: the optics must relay the NST focal plane image to the Coude room (beneath the telescope), which is about 3 m below the NST's Gregorian focal plane; the field-of-view for the optics must be 120" in diameter, so that wide field observations will be possible. We emphasize that the optical design of the NST is completed and implemented, and, as such, may be regarded as providing a well-defined light input to the downstream optics.

To deliver excellent optical performance, some of the optical components in the AO relay path will have to be custom-designed and manufactured. Figure 7 is the optical layout of the initial design for the new AO main optical path, which does not include the WFS.

The current AO-76 only corrects the chromatism at one wavelength and therefore cannot simultaneously work over the entire wavelength range of the visible and NIR, while the new design corrects this problem. We understand that a purely reflective system, which deploys only mirrors, is another attractive for broad-band imaging. Unfortunately such a system may not be possible for our AO system because both the tip/tilt and DM mirrors need to be located at a pupil image. A fast lens (L1 Figure 7) is needed to compress the telescope focal plane image to a small enough beam size on the tip/tilt. After the tip/tilt mirror, a re-imaging lens is needed to create a solar image before the collimator.

To make the reflective design more feasible, we plan to develop a larger tip/tilt mirror system. This larger tit-tilt will also solve the problem arising from a large photo-power density at the pupil plane (power six times larger than the current value for the 0.6 m telescope). We have investigated the Polytec PI S-340 system, which allows a mirror up to an aperture of 10 cm to be mounted, while the AO-76 tip/tilt has 1.5 cm. We understand that the larger tip/tilt system will suffer a reduction in the correction frequency. If we mount a 5 cm mirror to the PI-340 platform (as the design in Figure 7 uses for M1), the working frequency will

be 200Hz, instead of 800Hz for the current tip/tilt system. (CHECK FREQ.) The new tip-tilt system was developed with the ATI support.

A cubic beam-splitter will be located in the collimated beam after the DM, so that part of the light ( $\sim 5\%$ ) is used for wavefront sensing. Since the WFS works in a very narrow waveband ( $\sim 10\%$  of the wavelength) in the visible, commercial in-stock lenses could be used, and the chromatism would not be a concern. Table 1 compares the essential hardware components of the old AO for the 0.6 m telescope and the new AO for the NST. Again, we emphasize that the optical design will be a major effort in this proposed project. What we have demonstrated here is that we have the expertise to conduct the design work, and know how to proceed.

Figure 7 shows the most current AO-308 design with a combination of lenses and mirrors to optimize the performance. Figure 8 shows the spot-diagram in the visible range for the design in Figure 7. The AO design presented here will be finalized and reviewed by external review panel, once this proposal is funded. The circles in Figure 8 are the Airy disks (diffraction disks). The performance is close to diffraction-limited over the entire FOV and wavelength range. The design has even better performance in NIR. Like our current hardware setup for measuring magnetic fields (VIM and IRIM), NIR and visible will have two separate CCD systems with separate camera lenses. We do not need to adjust focus for either of the two benches when we switch wavelengths with AO-308. This is the major improvement over the old AO design for the 0.6 m telescope.

### A.2.4 Electronic, Computing and Mechanical Systems

Again, the principal system components for the AO system are: a correlating Shack-Hartmann WFS; a wavefront reconstructor and a deformable mirror (DM). Figure 9 shows the functional block diagram of the hardware that is basically applicable to the new AO. Dr. John Varsik at BBSO and Kit Richard at NSO will be in charge of the software development, and Dr. Thomas Spirock will design and construct the electronic system. Spirock has a Ph. D. in Electrical and Computer Engineering and is an accomplished instrument designer and builder at BBSO. Among many issues of software development, the reconstruction matrix (to convert from wavefront information to the movements of the actuators) needs to be made. For the electronics part, the following tasks need to be finished: (1) design and construct an interface to connect the WFS camera and the DSP board; (2) design and construct an interface to connect the DSP and tip/tilt; (3) Design and construct an interface to connect the DSP and the DM. The skeleton interface will be built by Bittware with a subcontract from this grant, and to be tailored by Kit Richard to fit our needs.

# A.3 Broader Impacts of AO-439 Project

### A.3.1 Relationship to Future Work and Nighttime Astronomy

This project is also an essential step to enable us to explore Multi-Conjugate Adaptive Optics (MCAO) in the future. MCAO is a further development of the AO concept, in which corrections are made by more than one DM. Each is conjugated to a different altitude, while with a single DM, a single isoplanatic patch is fully corrected (anisoplanatism). While MCAO is a promising technique for correction of atmospheric turbulence correction over a large field of view (Ragazzoni et al. 1999, Tokovinin, A. et al. 2001, Ellerbroek et al. 2003). Nighttime MCAO is difficult for wavefront sensing, since multiple laser guide stars are needed for the tomographic wavefront reconstruction. To accurately reconstruct 3-D turbulence, generally at least  $3 \sim 5$  laser guide stars are needed. Due to this and other difficulties, there is no nighttime MCAO that is currently in operation. The Sun is a natural target for extended object wavefront sensing; any number of "target stars" could be made from the 2-D structure of the Sun by using correlations from Shack-Hartmann wavefront sensing - the technique being using in our solar AO system. This provides an excellent opportunity to develop MCAO. However, this is an extremely difficult task and certainly is beyond the scope of this proposal. Nevertheless, once this proposal is funded, downstream we plan to build a dedicated WFS, which would allow wavefront sensing over a large field of view. The large field could be further divided into many sub-field for tomographic wavefront sensing. Data from such a wide field WFS would be collected and the 3-D tomographic wavefront turbulence would be constructed, which would eventually allow us to simulate and estimate the possible performance that would be achieved for an MCAO system. Constructing MCAO is not part of our proposed task, however, some testing data can be obtained with the proposed AO that may provide important information to build the MCAO in the future.

# A.3.2 Education and Research Training

NJIT has a diverse student body in an urban environment, with a large minority student population. BBSO highly prizes its special role in the education of the next generation of scientists who build instruments.

We currently have nine Ph. D. students (including 3 US citizens and 2 female students) who will receive Ph. D.'s from NJIT in various fields, ranging from applied physics to electrical and computer engineering to computer science. The very best NJIT students are attracted to the BBSO program. The typical student designs and builds the instruments used to make his/her Ph. D. measurements in BBSO. These students utilize the laboratories and our small observatory on campus to test the instruments for use at BBSO. BBSO also supports 2-3 undergraduate students for summer research at Big Bear.

We seek funding for a Ph. D. student and an undergraduate student. We believe that this project will be a strong draw for talented NJIT students who are already interested in instrument development. The graduate student will be trained during the the process of AO design. He/she will also assist the setup, observation and data analysis. In addition to the direct student participation in the project, the data will be important sources for graduate and undergraduate research. The telescope will also become a teaching tool for the optics, mechanics, computer control and solar physics.

#### A.3.3 Data and Telescope Time

Since NJIT began operating BBSO, its telescope time and data have been open to the community. Many scientists have had observing time. Further, several Ph. D. students from around the world are using BBSO data as a central part of the work for their theses. Data requests come to BBSO on a daily basis from around the world. We are an active participant in the Virtual Solar Observatory (VSO). Users of our telescopes and data are only asked to acknowledge BBSO in their resulting publications. Many observers have used our data to help plan their observing campaigns.

The observing time of the NST will be oversubscribed because of its much improved scientific capability compared to the old 0.6 m telescope. We will continue our open observing time, open data policy. We plan to make a portion of observing time available to the community. The Telescope Allocation Committee will rank the proposals and allocate time. For the NST data, if it is not part of a special observing program, it is open immediately. A web page describing all the requests will ensure that researchers will not duplicate the data analysis effort. If the data are from a special observing program, then we ask the PI of that program to coordinate with the requestor, and we would only intervene if that process were unsuccessful.

## A.4 Management Plan

During the building of the NST, we have assembled a strong instrumentation team. Part of the NST team will be shifted to the AO project during and as part of the commissioning phase. The AO work will not conflict with the NST effort. We already have our team in place to do the proposed work and we risk losing them and our momentum by delaying the start of the AO-308 project. PI Wang will manage the project and lead the science definition for the AO design. He will coordinate with the NST Project Director, Roy Coulter. Co-PI Goode will oversee the integration of the AO system and the NST, as he is the PI of the NST project. Co-PI Rimmele will supervise the optical and interface designs of the system. He will closely work with Kit Richard on the electronic interfacing and Jose Marino on WFS data analysis. As two PIs for NST and AO project are different, but work together, Prof. Goode can first concentrate on the alignment and setup of NST, while Prof. Wang will lead the development of AO.

In Table 2, we list the major proposed tasks of this AO project. The main tasks in the first year will be the optical, electronic and mechanical designs of the AO system, and then their interface to the focal plane instruments. NST will begin its commissioning phase in the middle of the first year. The main tasks in the second year will be fine-tuning of design and software development. The task for the third year is to set up the AO system, analyze WFS data and observe with the new focal plane instruments. Here are the detailed tasks:

(a) As soon as this project is funded, we will finalize the optical of the AO system, which must also relay the

telescope's Gregorian focal plane image to the Coude room where most of the AO components are located on an optical bench. This includes the design of the optics for the WFS, for which a  $15'' \times 15''$  field of view will be imaged on its lenslet array and the CCD detector for wavefront sensing. The WFS will be carefully tested with our single-mode fiber interferometer to make sure that it has minimal optical aberration. In addition, we will iteratively test the main AO optics with the interferometer until the main optical system is well-aligned. All parts will then be integrated as a whole system, and trial observations will be conducted to make sure that the whole AO system works properly. Dr. Rimmele will lead the design review to ensure that the design is optimized.

(b) It is well-known that for a regular AO system, the high bandwidth correction requirement allows only partial correction. Also AO is not so effective for large fields of view because of anisoplanatism. The solution, when one does not require very high temporal cadence, is to post-process the data into subfields smaller than the anisoplanatic patch, which for many applications is on the order of 5". The problem is to separate the object and the aberrations, two unknown quantities, in the images in the presence of noise, a third unknown. To obtain corrections in a larger field of view, BBSO is developing Phase Diversity (PD) system. PD utilizes a model of the image formation process to constrain the estimation of the aberrations and the common object in two image channels with a known difference in the pupil phase, usually a focus shift. An image collected in this second optical channel will contain the effects of the unknown phase aberrations, but also will be influenced by the intentional defocus, which adds a known quadratic phase. Obviously, the phase information from a PD system will help us to analyze the wavefront information of the AO system.

(c) Since the Fabry-Pérot systems will be our primary science instrument, they must be in a very mature stage before the end of the second year. Dr. Cao will continue work on the NIR and the visible system, so that both will be fully exercised with the current AO at BBSO and NSO/SP and be ready to be integrated into AO-308.

(d) A key component in the AO development is to analyze the wavefront data to evaluate the operation of the AO, and guide the modification of the system. Jose Marino will concentrate on this project as he has significant experience in handling wave front analysis for AO-76.
