## 2 Scientific Rationale

#### 2.1 Title

#### Magnetic activities along inter-granular lanes and their role for coronal heating and material ejection

#### 2.2 Abstract

Following previous notable achievements made with NST, we would like to observe magnetic activities (reconnection) along inter-granular lanes driven by convection motions with the aim to explore the nature of magnetic reconnection and is roles in coronal heating and small-scale jet events. Since it is believed that the small-scale reconnection is ubiquitous in the lower atmosphere, we have no preference for specific regions, though we have a preference for active regions. We will apply coordinated observations by IRIS and/or HINODE.

#### 2.3 Short Summary of the Request

We would like to observe high-resolution magnetograms with NIRIS and small-scale activities with VIS in  $H_{\alpha}$ . High-resolution observations of photosphere with BFI at TiO 7057 Å is required. For the purpose of this scientific aim, we require VIS observations extend to  $H_{\alpha}$ continuum for a precise co-alignment with photosphere and corresponding magnetogram.

#### 2.4 Scientific Rationale

Coronal heating is a long standing problem in astrophysics. For solving this problem we need simultaneous high-resolution observations from the solar photosphere (including magnetogram) to the corona. This requires both ground-based and space-based observations for cold and hot atmosphere respectively. Thus, for NST and its instrument NIRIS, it is a timely topic considering HINODE, SDO and IRIS are working very well in orbit. With the advent and successful running of NST, solar observation has entered the era of 0.1 arc second. This permits us to carry out case studies for a single coronal heating event, accumulating original highresolution observational evidences for a final resolving of the coronal heating problem. In previous studies made with NST by Ji, Cao and Goode (2012), they reported the first direct observations of dynamical events originating in the suns photosphere and subsequently lighting up the corona. In their paper, continuous small-scale, impulsive events have been tracked from their origin in the photosphere on through to their brightening of the local corona. For two heating events, Yang et al. (2015) found that the two events are rooted at one side of magnetic polarity inversion line. Even with low-resolution HMI magnetograms, they found that one event is apparently accompanied by the disappearance of a tiny magnetic element while, in another event, weakening of a magnetic concentration area is found. Changes for granules are also found during the two events.

Also with NST observations, we discovered the first evidence of magnetic reconnection driven by advection in a rapidly developing large granule using high spatial resolution observations of a small surge event (Zeng, Cao and Ji) (Figure 1). The results suggested that heating events and small-scale ejections are caused by magnetic activities in inter-granular lanes driven by constant granule convection. It appears that ubiquitous small-scale magnetic activities produce outflow of cold matter and hot matter (Yang et al. 2015). We need further well-devised multiwavelength high-resolution observations, especially, high-resolution magnetograms to confirm this physical picture.

(1)-(6): Time series of contours of line-of-sight magnetic field. The contours are overlaid on simultaneous TiO images when they are available. Red and blue contour represent positive and negative magnetic field, respectively, with contour levels at  $\pm 10, \pm 30, \pm 50$  (thick contours), and  $\pm 100$  Gauss (thick contours).

#### 3.2 Observational Strategy

1) What types of data are urgently needed?

Simultaneous TiO 7057 Åimaging, VIS observations around  $H_{\alpha}$ , magnetograms at 1.56  $\mu$  with NIRIS are equally important.

2) What are the typical cadence?

For TiO 7057 Åimaging, we need cadence of 15 seconds. For VIS line scan, we need  $\pm 0.6$ ,  $\pm 0.8$ ,  $\pm 1.0$  Åat the cadence of 10 seconds. As for NIRIS, as a first step, we would like to have only V-component with high cadence,

As stated above, we will apply coordinated observations by IRIS and/or HINODE. If it is not successful, we will try to follow the regions targeted by IRIS and/or HINODE.

\*VIS line scan currently includes 11 optional wavelength points of  $0.0, \pm 0.2, \pm 0.4, \pm 0.6, \pm 0.8, \pm 1.0$  Å. Please specify the cadence and wavelength points carefully since your decision will affect the total amount of data we collect. The minimum cadence is 25 sec for a 11-point line scan and 3-4 sec for a 2-point line scan.
