## 2 Scientific Rationale

#### 2.1 Title

#### High Resolution Observation of Active Region Filaments

#### 2.2 Abstract

We are going to study the twist structure of active-region filaments. We will also study the morphological and dynamic properties of the mass motions in and around filaments.

#### 2.3 Short Summary of the Request

A twisted magnetic flux bundle, i.e., a magnetic flux rope, is a crucial configuration for hosting chromospheric material showing as a filament. To a great extent, our knowledge of the magnetic reconnection/eruption scenario depends on how well we can characterize in quantitative detail the structure and topology of a magnetic flux rope and its embedding field. Moreover, mass motions in and around filaments have attracted a great deal of attention from solar physicists, since the investigation of this motion may provide important clues to magnetohydrodynamic instability in filaments and also sheds light on the still not well understood filament formation process. Using BBSO high-resolution off-band H $\alpha$  filtergrams, Zirker, Engvold, & Martin (1998) found a type of filament motion that is in the form of counter-streaming flows, at speeds of  $5-10 \text{ km s}^{-1}$ . Another type of large-amplitude oscillatory mass motion was also identified using the BBSO H $\alpha$  camera system (Jing et al., 2003; Jing et al. 2006). The oscillatory motion is along the filament axis with a very high velocity amplitude of  $\geq 30 \text{ km s}^{-1}$ , and are often associated with nearby flares.

Observation of twist structure of filaments and detection of mass motions require high spatial resolution images and time-series of observations over several hours. The high resolution ability of the NST instruments is very suitable for our scientific goal. We will collect BFI G-band or TiO images, VIS H $\alpha$  images and NIRIS Stokes data, which forms the key components of the expected data set for the proposed study.

#### 2.4 Results from Previous NST Observations

Taking advantage of the high-resolution and high-cadence of the NST, we found the rapid formation of sunspot penumbra that is closely associated with the C7.4 flare of NOAA active region (AR) 11515. The formation of penumbra is substantiated by the transformation of the solar granulation pattern into penumbral fibril structure, and is accompanied by the persistent penumbral darkening and the horizontal field enhancement.

#### 2.6 Expected Results

We expect to observe the twisting structure in filaments in great detail and how it evolves. We also expect to capture the mass motion in and around filaments.

## 3 Observing Programme

#### 3.1 Instrumentation Requirements\*

#### **3.2** Observational Strategy

This section is devised for you to address following issues:

1) what types of data are urgently needed?

We plan to obtain time series of high resolution G-band or TiO images,  $H\alpha$  imaging spectroscopic data and magnetograms, using BFI, VIS and NIRIS respectively.

2) what are the typical cadence, preferred observing mode, wavelength points for VIS line scan and NIRIS line scan range?

When seeing is good, we would like our observations to have the highest cadence available. Typical cadence desired is 10-20 s. If seeing is not very good, the cadence can be lower to save data volume. For VIS, we would like 5 wavelength points at 0.0,  $\pm 0.4$  and  $\pm 1.0$  Å. For NIRIS, we propose to obtain Stokes IQUV spectra for the Fe I 1564.85 nm line covering  $\pm 1.3$  Årange.

3) whether you desire image reconstruction especially for VIS data?

4) other space-borne and ground-based instruments for coordinated observations?

\*VIS line scan currently includes 11 optional wavelength points of 0.0,  $\pm 0.2$ ,  $\pm 0.4$ ,  $\pm 0.6$ ,  $\pm 0.8$ ,  $\pm 1.0$  Å. Please specify the cadence and wavelength points carefully since your decision will affect the total amount of data we collect. The minimum cadence is 25 sec for a 11-point line scan and 3-4 sec for a 2-point line scan.

## 3.3 Target and Conditions

We would like to observe active-region filaments on disk. Specially, an ideal target would be a filament that locates in a complex active region with strong potential of flare productivity. Our proposed observations require good seeing conditions.
